1. Visa-free entry privilege for Swiss and Liechtenstein nationals and other nationals covered by Executive Order No. (EO) 408 for a maximum stay of 30-days in the Philippines resumed on 10 February 2022. Any extension of the said maximum 30-day or 59-day stay is within the purview of the Bureau of Immigration (BI), which has the sole mandate and prerogative regarding the entry, stay and exit of foreigners into the Philippines. Applications for extension of stay while in the Philippines must be lodged directly with the BI. Please visit the BI website / weblink on non-immigrant visa (Temporary 9A visa):

All temporary visitors (except those availing themselves of the Balikabayan Privilege) are required to have valid tickets for their return journey to the port of origin or next port of destination corresponding to their permitted/allowable duration of stay in the country under a valid visa or visa-free entry, as the case maybe.

- Balikbayan Visa Privilege for the legal spouse or children of Philippine nationals and/or former Philippine nationals travelling with the said Philippine national or former Philippine national also resumed on 10 February 2022. - 3. The application for and issuance by the Embassy of the Non Quota Immigrant Visa [13(A)] visa has also resumed.

A 13(A) Visa is a single-entry visa, which is initially valid for one (1) year, can be issued to the qualified non-Filipino spouse (including Swiss) of a Filipino citizen. It may be renewed in the Philippines for three (3) consecutive years and on the fourth year, the applicant may apply for permanent residency in the Philippines.

- **5.** A health insurance coverage for foreign travelers is highly recommended but no longer required.

6. Applications for Temporary Visitor (Tourist) Visa for 30 or 59 days can be applied for and be issued by the Embassy. All visa applications must be initially lodged online through the Philippine Visa Online Portal, i.e., https://www.visa.gov.ph/ Please refer to the Instruction on How to Accomplish the Philippine Visa Online Portal. After completing the online visa application, please email your visa application reference number (found on the upper right-hand corner, below the barcode of the application form) to the Visa Section at: bernepe.visa@dfa.gov.ph for verification. Note that submitting the application form through the portal does **NOT** mean your visa is already in process. After verification, applicants will be advised by email regarding the submission of the signed visa application form, passport, and appropriate documents based on the visa category, and fees to the Philippine Embassy by registered mail (Einschreiben). 7. The Embassy is not authorized to process applications for SRRV (Special Resident Retiree's Visa) and SIRV (Special Investor's Resident Visa) or renewals thereof, including Alien Certificate of Registration (ACR).
