3.	Provide (1) one storage rack for 4 water bottles;

5.	Conduct a regular maintenance service;	
6.	Offer a warranty on all water dispenser parts;	
7.	Offer free delivery service (up to the stock room of the Embassy); and	
8.	Provide a focal person to handle the account of the Embassy for easy coordination and transaction.
