**Technical Specification
Restoration of Philippine Embassy's Two (2) Main Period Doors**

I.	Background: The Embassy will undertake the restoration of the Embassy's two (2) main period doors.	
II.	Objective: To hire professional services to restore the Embassy's two (2) main period doors.	
III	Scope of Work: The Contractor shall undertake the following:	Statement of Compliance
	<ol style="list-style-type: none"> 1. Scraping of the old paint/polish on both sides (in and out) of the main doors; 2. The main doors will be repainted on both sides according to their original brown color and protective coating against the weather applied. 3. The current outside door knobs that are made of solid golden brass will not be replaced but will be restored to their original golden colour; 4. To install inside handles on both doors that are made of solid golden brass materials to be provided by the Embassy; 5. Provide adjustments necessary on the re-installation of the two (2) doors; 6. Attach a wooden replica on the inner side of the doors to conceal view of the key cylinders attached on the doors; 7. Provide temporary replacement security doors while the two (2) main doors are undergoing the restoration process. 8. Install door stoppers at the two (2) main doors 9. Fix any damages, abrasion/scratches on the walls and door hinges which may result from the execution of the project.
