	The Philippine Embassy will undertake the project "Renovation of the Philippine Embassy Chancery's two (2) kitchens located at the third floor, East and West Attic Apartments.	
II	Objective	
	To hire professional services for the renovation of the Philippine Embassy Chancery's two (2) kitchens located at the third floor, East and West Attic Apartments.	
III	Scope of Work	
	The Contract shall undertake to renovate the two (2) kitchens located at the 3 rd floor, east and west attic apartments with the following specified works:	
	 Dismantle and replace all old kitchen cabinets and cupboards; Dismantle old counter-tops and replace them with new counter tops made of granite or black stone; Dismantle and replace the existing kitchen sinks and faucets; Dismantle and replace the old kitchen appliances e.g. cook top with 2 burners, built-in refrigerators and the dishwasher at Kitchen No. 1 (East Wing apartment); Provide professional plumbing and electrical services; and Shall repair/paint walls that may be affected with regard to the execution of the projects. Shall be responsible for the disposal of dismantled cabinets, appliances and debris from the old kitchens

	 Provide a detailed design of the kitchens; Provide professional and duly licensed crew; Provide its crew with appropriate protective gear to carry out the project Provide equipment and other tools necessary to undertake the work; Provide mandatory accident and other form of insurance as required by Swiss laws for the crew; Ensure that the integrity of the building is safeguarded and not compromised; and shall be responsible for the disposal of the dismantled cabinets, appliances and debris from the old kitchens; The Company shall be based in Switzerland; Accept MWST or VAT exemption; and Submit the invoice within 7 days after completion of the project.
